Proposed Changes to HMP YOI Ashfield Parish Council Summary

The process by which the Parish Council was made aware of the Ministry of Justice plans to re-role the YOI as a Category C Male Prison and the actions the Council has taken to acquire accurate information have already been shared in previous editions of Pucklechurch News. The Council has however continued to take a proactive role on behalf of the community with important outcomes.

At the Council meeting scheduled for 20th February, Brian Pollett, (Deputy Director of Contracted Custodial Services), Brian Anderson (then Director HMP YOI Ashfield) and Simon Harding (NOMS Deputy Controller HMP YOI Ashfield) were due to present information on the planned changes as well as make themselves available to answer Councillors' questions under the Public Participation section of our agenda. As the result of widespread media and other coverage promoting this as a general public meeting, the Council arranged to relocate the meeting to the Community Centre Social Club in order to be able to accommodate a larger number of attendees. The Council also agreed to suspend its formal meeting for a period of one hour to allow a free and open debate between residents and the representatives of Ashfield YOI who were happy to oblige. Steve Webb MP and District Councillor Ben Stokes were also present.

On Tuesday 5th March a further public meeting of the parish was arranged by the Parish Council in direct response to a parishioner's request. This meeting provided an opportunity for the local community to discuss what actions, if any, could be taken to address the planned changes. Ray Duckworth (Serco Contract Director, HMP YOI Ashfield), Nick Lewis (NOMS Controller, HMP YOI Parc and Ashfield) as well as Simon Harding (NOMS Deputy Controller, HMP YOI Ashfield) agreed to attend to answer further questions. This meeting was also attended by several Parish Councillors, two District Councillors, a representative of the Police & Crime Commissioner's Office and two senior CID officers. (Cont. on page 2)

The information presented below is not an exhaustive report on all the discussion that took place but an attempt to summarise the main concerns, facts and outcomes that materialised.

A broad range of concerns were expressed over:

- why the prison was being used to house sex offenders as opposed to any other Category C prisoners and why it was particularly appropriate to Ashfield
- populating Ashfield entirely with sex offenders causing a real hindrance to the effectiveness of rehabilitation programmes and what those programmes would be
- types of visitors coming to Pucklechurch and that these may also be sex offenders, which could put the safety of residents at risk and how visits would be managed
- sex offenders being detained/released in close proximity to a school and local play areas and the possibility of offenders wishing to remain/settle in the local area after release
- guarantees that could/couldn't be given over management of offender release/public safety
- the problem of parking since operating the prison at full capacity will attract more visitors
- the consequent loss of opportunity for other types of offender rehabilitation
- the potential impact the change might have on local policing and ability to respond
- the potential impact on the well-being of the community as well as on property values
- the lack of consultation and poor sharing of information with the public in advance

Details regarding the changes and responses to issues raised can be summarised as follows:

- A drop in the number of 15-17yr old offenders means Ashfield has been operating at half-capacity for the last 18 months. Consequently it will be made available for Category C adult male prisoners from this summer whilst young offenders will be sent to other establishments
- As a new purpose built establishment the Ministry of Justice believes it has a duty to use Ashfield appropriately and to help solve the greatest need. It will therefore be used to detain 400 Category C adult male prisoners, all of whom will be sex offenders
- Category C prisoners are deemed to be at reasonably low risk of attempting to escape but not suitable for establishments such as open prisons.

Prisoners held at Ashfield will be unsuitable for release on licence to work in the community and it was unlikely that this would ever happen

- The number of days available for visiting will be reduced from 6 to 4 and the number of staff employed there will be also be reduced so this may alleviate some problems over parking
- Training programmes will put in place for those staff that remain and Serco will be contracted to provide appropriate treatment and rehabilitation programmes, the specific details of the contract are still being determined
- It is planned that when offenders are released arrangements will be made for them to be collected by family/friends or taken by Serco to train/bus stations. Experience shows that the vast majority return to their home areas, London or the main cities.
- Serco and the Ministry of Justice believe there will minimal or no impact of the re-role for Pucklechurch as a community.

Outcomes:

Serco and the Ministry of Justice have entered into a dialogue with the community and listened to their concerns. The main issue for residents who attended was not that there shouldn't be a prison at all but that the type of offender and the subsequent management protocols required to deal with them were. It is hoped that the authorities will now address these concerns appropriately.

Steve Webb MP reported that he had been in touch with the Ministry of Justice and that contracts had not yet been signed. He has also tabled questions to be answered. Ben Stokes and Steve Reade have been collecting information via a public survey to demonstrate the depth of local feeling and were happy to continue to receive more comments. The Police & Crime Commissioner's Office representative has confirmed they will be writing to the Ministry of Justice with their own concerns especially with regard to the management of offender release.

As a direct result of the second meeting a group of parishioners have now formed a committee to look at what community action can be undertaken to influence the decision and the future management of its consequences. This will likely take the form of a letter to gather public support distributed to residents through Pucklechurch News and will be presented along with their plan to the Parish Council on Weds. 13th March.

Pucklechurch Community Association Committee Report

The PCA Committee has had a very busy year keeping the building prepared for the different groups to use. The Committee would especially like to thank John James. His persistent and constant scrutiny of the heating system and lighting has been indispensable, so that the heating functions more reliably and the lighting is always working.

The Committee has also started looking closely at the various regulations required and has begun an updating programme. Fire escape exits have been checked and emergency lights and more signs have been installed.

The Committee has also started a programme of improvements and modernizing. This is a slow process as it is dependent upon the income generated from bookings and successfully obtaining available grants. Visitors to the building will have noticed the new lobby floor, new internal doors and signs around the building. The Committee is delighted with the many positive comments that have been heard.

The Committee intends to continue both programmes because the number of groups that now use the hall on a regular basis is significant. Around 18 different groups now use the hall weekly or monthly in addition to groups that use it regularly annually or bi-annually.

For this facility to remain available for the community to use an effective committee is necessary. The AGM takes place on Monday 13 May 2013 at 8.00pm in the Community Centre Meeting room. It is **vital** a committee is formed to manage the building. The concern is that this may not happen. We have a secretary who is reinstating the role and who is prepared to continue for the next year, but several key positions are being vacated. The treasurer, chairman and vice chairman are resigning. **Unless these positions** are filled so that the committee can effectively manage the building there will be **no option** but for the committee **TO CLOSE THE BUILDING**.

Our present Treasurer, George Hill, has done a wonderful job collating the finances and ensuring that we keep within our limits. We would like a treasurer who can help the committee access the many grants that are available. The chairman, Alan Holder, has done a magnificent job of guiding the committee and overseeing the various projects. Anyone prepared to become chairman will have the support of the rest of the committee and the support of the outgoing chairman, who is going to remain on the committee.

Ash Dieback Disease Scam

South Gloucestershire Trading Standards would like to warn residents of a new scam emerging in the South East of England, but which may spread to the South West as Spring approaches.

Trading Standards departments in the South East have reported that rogue traders are targeting householders with ash trees on their property, falsely claiming that trees need to be felled or pruned due to ash dieback disease.

Chalara dieback of ash, often referred to as ash dieback is a disease of ash trees caused by a fungus. The disease causes leaf loss and dieback in affected trees and depending on the age of the tree can lead to tree death. Tree owners are not required to take any particular action such as felling the infected ash tree, unless a statutory Plant Health Notice has been served on the owner. A Plant Health Notice can be issued by the Forestry Commission or other plant health authority. Once infected, trees cannot be cured, but not all trees die of the infection. Young ash plants can be killed within one growing season of symptoms becoming visible, whilst older trees can survive initial attacks, although they may die after several seasons of infection.

LIVE MUSIC IN PUCKLECHURCH



Do you play an instrument? Do you like watching live music? Pucklechurch Open Mic could be the place for you. For those that have never been to an open mic (short for microphone) night, these are nights when performers get a chance to take to the stage and do their stuff. Usually the performers are musicians. They serve a very important function in the music scene by providing an opportunity for musicians to gain experience performing to a live audience without having to go through the process of getting normal music gigs. It also gives established musicians a chance to try out new material, brush up on their act or perhaps perform with different instruments or people.

In February Pucklechurch Open Mic celebrated its second anniversary and over the last two years we have gone from strength to strength. We have many acts from the local area and are also attracting performers from Bristol and surrounding areas. I am very pleased to say we have helped some young local acts move from practicing in their bedrooms to performing gigs.

We are very lucky to have a good venue. We have a stage and PA system with a sound engineer to make sure our acts sound their best. But it's not only about the musicians. It is also about having an audience. So, if you like live music, come and join us. We can't tell you what will be on but we usually get between three and eight acts. The range of music is quite varied and we have seen almost all modern genres covered at some point with even an occasional classical piece. We also get a good mixture of covers and original material. We have solo musicians, duos, trios as well as small groups. We even have a ukulele orchestra turn up from time to time! Pucklechurch Open Mic is held the last Friday of every month from 8.30pm at the Pucklechurch Village Sports and Social Club (PVSSC), also known as the 'Top Club, in St. Aldam's Drive. It's Gutter Rubbish

South Gloucestershire Council Trading Standards would like to remind residents to be cautious when dealing with unexpected traders at their front door.

Trading Standards has recently received complaints from residents of South Gloucestershire about cold callers offering to clear gutters after they 'spot a problem'. The caller arrives with ladders and buckets and negotiates the charge of £15 for each side of the house. It has not been possible to establish whether any work is actually undertaken and this approach has been linked to a number of distraction burglaries. Avon and Somerset Police are aware.

The advice being offered is to treat all unexpected caller with suspicion. Always use door chains and do not agree to any work on the doorstep. If you feel intimidated or threatened at any time, contact the Police on 101 immediately.

Access to Our Countryside

The Pucklechurch Countryside Access Group was formed last year from an action in the Community Plan to make the wonderful countryside around our village more accessible.

2012 activities centred around two main projects. The first was cycle tracks and the big effort of 2012 saw the completion of the Coxgrove Hill to M4 section of the Yate extension to the Bristol-Bath cycle track. Volunteers from Pucklechurch gave massive support to the completion of this section and this was reported in detail in an earlier issue of Pucklechurch News. Work on the next phase from the M4 to Westerleigh Road has been hampered by weather conditions. If it stays dry it is hoped work can start again at the end of February. If you want to help please email Matt Skidmore at the email address below.

The other area tackled was access to the footpath network around the village. Stage one is to walk the paths and survey them. Stage two is to publish the information and to improve signs and way markers. We are helped by existing information from Ros and Mike Abbott (Footpath Wardens), and Les Whittock who wrote a footpath guide many years ago. Unfortunately circumstances conspired against me and we only surveyed three routes in 2012. In order to get this rolling in 2013 I am proposing walks on the following dates:

Community Car Scheme for Pucklechurch

However, today it will be nigh on impossible. The Community Plan identified that a Community Car Scheme would help address the needs of our community.

Community Car Schemes are a means for local volunteers to provide much needed transport for local communities. Hundreds of schemes are already in operation around the UK and the Parish Council have just secured a grant from South Gloucestershire Council to start one in Pucklechurch.

Volunteers Needed to Run the Scheme

These schemes are run by volunteers and they do not happen without support from the community. Initially we need a small group to decide what our community needs and how the scheme will operate. Every community is different and we can tailor how this works to our local needs. After that we need a small organising team to coordinate the operation and a number of volunteer drivers.

Good Neighbour Scheme

The Pucklechurch and Shortwood Good Neighbour Scheme is going from strength to strength. Volunteers are continuing to help members of our community with tasks like putting bins out, dog walking, changing light bulbs and spending time with people for a cup of tea, providing company and support. The co-ordinators have also been receiving new calls. At a good neighbour scheme meeting held at the Rose and Crown on the 7th February, a number of new volunteers were welcomed.

We are considering expanding to Hinton, Abson, Dyrham and Doynton. However, this will not work until there are volunteers there. We are looking to seek some advice and financial help for this because we will need to deliver leaflets to every household in these areas to assess whether this is a viable option. We will be requesting this help and advice at the next meeting of the Safer Stronger Community Group and will keep you updated.

The scheme has used funding to print 500 leaflets. These will be placed in holders in key locations around the village for residents to pick up and read to promote the scheme. We have also put some leaflets in plastic pockets with a good neighbours pen and magnetic business cards. These can be given to people interested in the scheme to look through when they are considering using it. This pack provides information about what we do and full contact details.
